Opening

The EFOSA 43rd General Assembly Meeting (GAM) took place in Santiago de Compostela, Spain on Tuesday, June 19, 2012.

President Alexandros Kokkas opened the meeting at 9:30 a.m. thanking the Spanish orthodontic community for everything they have done to help EFOSA. There were 35 participants present from 22 countries, each whom introduced themselves.

The President reminded the General Assembly of the death of **Juri Kurol** and asked the delegates to stand for a minute's silence.

New EFOSA Full Member

The GAM unanimously accepted the application for full membership of Luxembourg which was submitted by Odile Hutereau.

Reports

The President Alexandros Kokkas, the Secretary Julian O' Neill and the Treasurer Christian Scherer presented their reports. The GAM accepted the financial report. The EFOSA accounts were audited by Owen Crotty and Lutgard De Ridder.

The EFOSA Projects

President Alexandros Kokkas provided a powerpoint presentation on the European Orthodontic Guide. In this, he described its history where Franz van der Lin-

den, Luc Dermaut and Wolfgang Schmiedel had initially collected the data. This had been first produced as a poster in Paris in 2005 and then in Sydney in 2010. He also stated that to date 23 out of the 28 country members had responded. The Guide will be completed next year.

Secretary Julian O'Neill described the concept of updating the website to provide administrator rights to individual country members. This would make individual country members responsible for updating their own information. Vice President Bart Vande Vannet gave a detailed powerpoint presentation on the production of radiation guidelines by EFOSA. Jonathan Sandler suggested that the articles be placed on the website.

Guest Speaker



Professor Stavros Kiliaridis of the Geneva University, provided a presentation on postgraduate education in Europe and NEBEOP. He explained what is NEBEOP and what it is trying to achieve. He also

provided an update on activities. He stated that we need to move ahead with NEBEOP and that more countries will need to have their programmes signed up if this is to be a success.

The Prof. Charles Bolender Award

It was announced that Prof. Charles Bolender had happily agreed to allow

his name to be appended to this award. Julian O' Neill suggested the concept that this award should be provided to a postgraduate in orthodontics who would carry out a project related to EFOSA's activities. This could take the form of a survey of postgraduate training throughout Europe. The award would have competitive entry and the winner would carry out his research and then present this at a future EFOSA meeting. It had been agreed that an award of 1,000 Euros and up to 500 Euros for expenses would be made available.

Elections

The GAM unanimously elected Eva Sramkova (Czech Republic) as the new member of the Council. She will replace Ewa Czochrowska who will host the 2014 EOS Council in Poland.

For the Nominations Committee Martina Drevensik (Slovenia) was elected.

Auditors were elected: Alain Vigie du Cayla (France) and Kristin Heimisdottir (Iceland).

Other Business

Claude Bourdillat discussed the issue of recycling brackets. She told the delegates that there would be an EU directive in 2015 regarding this.

Jonathan Sandler provided a presentation on the upcoming 8th IOC meeting in London planned for September 2015 and reminded delegates to sign up early in order to enjoy a reduced registration fee and VIP events.

Finally, the President thanked all the delegates for their presence and closed the GAM. The next EFOSA GAM will take place in Reykjavik, Iceland, in June 2013.
